

Terms of use

Access to the site www.alymodecreation.com is open to anyone wishing to learn about the articles marketed by **AMC** and more generally on African arts.

The purpose of these General Conditions of Use is to define the terms of provision of the services of the site en.alymodecreation.com (hereinafter referred to as the "Service") and the conditions of use of the Service by the user (hereinafter -after named "User").

Acceptance of these General Conditions of Use
